ORDINANCE OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING ORDINANCE #01-2020 ENTITLED "ORDINANCE OF THE BOROUGH OF SHIP BOTTOM, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 13.04 OF TITLE 13 OF THE BOROUGH CODE OF THE BOROUGH OF SHIP BOTTOM ENTITLED "WATER SERVICE SYSTEM" SO AS TO ESTABLISH REGULATIONS PERTAINING TO WATER METERS" TO REQUIRE CERTAIN METER INSTALLATIONS WITHIN 90 DAYS OF NOTIFICATION FROM THE BOROUGH

BE IT ORDAINED, by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 1 of Ordinance #01-2020 is hereby amended and supplemented to revise Paragraph I of Section 13.04.050 to read as follows:

I. Effective January 1, 2020, the Borough will supply and install 1" meters, meter pits and assembly, including connections to the Borough's water supply system, for all residential buildings or structures within the Borough, including meter replacement. Any meters exceeding 1" shall be the responsibility of the property owner at the property owner's sole cost and expense and shall be installed by the property owner within 90 days of notification from the Borough.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid of unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

SECTION 4. This ordinance shall take effect after public reading and publication as required by law.


