

ORDINANCE NO. 15 OF 2021

**ORDINANCE OF THE BOROUGH OF SHIP BOTTOM,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AMENDING AND SUPPLEMENTING CHAPTER 12.12 OF
THE BOROUGH CODE OF THE BOROUGH OF SHIP
BOTTOM ENTITLED “BEACH AND BAY AREA USE
REGULATIONS” SO AS TO REGULATE THE BOARDING
AND DISCHARGE OF PASSENGERS FROM VESSELS
WITHIN CERTAIN AREAS OF THE BOROUGH-OWNED
BAYFRONT**

BE IT ORDAINED, by the governing body of the Borough of Ship Bottom, County of Ocean, State of New Jersey, as follows:

SECTION 1. Chapter 12.12 of the Borough Code of the Borough of Ship Bottom entitled “Beach and Bay Area Use Regulations” is hereby amended and supplemented to add new Section 12.12.121 entitled “Boarding or discharge of passengers - Prohibited” which shall read as follows:

12.12.121 Boarding or discharge of passengers – Prohibited.

It shall be unlawful for any owner or operator of a vessel as defined in Section 12.12.120(A), to board or discharge passengers at any borough-owned dock, pier, breakwater, bulkhead or shoreline beginning at a point from southside of Ninth Street and extending southward to the southside of Sixteenth Street except when launching or retrieving a vessel in accordance with the provisions of this chapter.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

SECTION 4. This ordinance shall take effect after public reading and publication as required by law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed by the Borough Council of Ship Bottom Borough on first reading at a meeting held on the 27th day of July, 2021. The Ordinance will be considered for second and final reading at a meeting of the Borough Council which is scheduled for the 24th day of August, 2021 at 6:30 p.m., or as soon thereafter as the matter may be reached, at the Municipal Building located at 1621 Long Beach Boulevard, Ship Bottom, New Jersey, at which time the public is invited to ask questions, raise objections, or provide public comment with regard to the proposed adoption of this Ordinance.

The Borough of Ship Bottom introduced the above ordinance at its July 27, 2021 meeting. The Ordinance amends and supplements Chapter 12.12 of the Borough Code of the Borough of Ship Bottom entitled “Beach and Bay Area Use Regulations” so as to regulate the boarding and discharge of passengers from vessels within certain areas of the Borough-owned bayfront. The ordinance will be considered on second and final reading at the August 24, 2021 meeting of the governing body.
